TREASURER'S REPORT 2013

January 21, 2014

To the PBA Board and Members

Regular Income was again encouraging with \$ 25,950 Dues at 81 % participation, a high water mark compared to recent records and memory.

Expenses were fairly normal. Fixed are of course steady. Additional Sponsored Events were successful. The net expense there shows as only \$ 284 after crediting income (\$ 1,443) from the smash hit Comedy Night.

Reserves of about \$29,000 are prudent at about one year of expenses.

Summary: After budgeting for a \$4,000 deficit, we actually had an operating surplus of \$5,275. This was a result of solid income and failure, due to delays, in starting or completing previously approved and budgeted projects (ventilation and painting).

It would be great to continue improving dues collection. If difficult for some, we encourage everyone to pay something. No questions asked. It is hoped that the Board and Members continue preservation of our property and the kids and adult programs. Storm damage on the beach is always a priority.
