TREASURER'S REPORT 2014

January, 2015

To the PBA Board and Members

<u>Regular Income</u> was again encouraging with \$ 24,950 Dues at 77 % participation, not a high water mark but still above historic averages. Total income was \$ 26,548. We had an operating Surplus of \$ 7,271. Fund Balance (Reserves) are at \$ 36,631.

Expenses were fairly normal. Fixed Costs are of course steady. Additional Sponsored Events were successful. The net expense for Sponsored Events was only \$ 38 after crediting income (\$ 1,181) from the smash hit Comedy Night.

<u>Reserves</u> of \$ 36,631 are prudent at about one year of expenses plus the as yet finished capital expenditures which were budgeted and approved previously.

Summary: After budgeting for a deficit, we actually had an operating surplus of \$ 7,271. This was a result of solid income and failure, due to delays, in starting or completing previously approved and budgeted projects (ventilation and exterior).

It would be great to continue improving dues collection. If difficult for some, we encourage everyone to pay something. No questions asked. It is hoped that the Board and Members continue preservation of our property and the kids and adult programs. Storm damage on the beach is always a priority. Our work permit extension has been applied for after 4/26/15.
